### Letter of Agreement (LoA) for Research Project entitled "Mangrove Restoration in Banyuasin Regency, South Sumatra"

The Center for International Forestry Research ("**CIFOR**"), in close collaboration with its partners, has submitted to Temasek Foundation International (TFI) a proposal entitled "**Mangrove Restoration in Banyuasin Regency, South Sumatra**". The proposal has now been accepted for funding, and CIFOR is pleased to grant to Center of Excellence Peatland Conservation and Productivity Improvement (CoE PLACE), Sriwijaya University, [Center's establishment number: under Universitas Sriwijaya Rector's Decree no. 0367/UN9/SK.BUK.KP/2018] ("**Subgrantee**") the sum of **IDR 456,602,414** ("**Subgrant Funds**") in accordance with the Terms of Reference described in Annex 1 of this LoA ("**Research Project**") and following terms and conditions:

### **ANNEX 1: RESEARCH PROJECT**

### Background

Indonesia has about 3 million hectares of mangrove forest growing along its 95,000 km coastline and accounts for 23 percent of all global mangrove ecosystems. Mangrove ecosystems are important in terms of carbon stocks, biodiversity and livelihoods for communities. A hectare of mangrove can store 3-4 times more carbon compared to terrestrial forests. Across Indonesia in the last three decades, about 40% of the original mangroves have been lost, leading to significant annual greenhouse gas emissions.

In South Sumatra province mangrove ecosystems are found along its eastern coast. The South Sumatra mangrove ecosystem occurs in two regencies, Banyuasin and Ogan Komering Ilir (OKI). Within South Sumatra province, mangrove coverage has declined from about 210,000 ha in 1990 to 176,000 ha in 2019. There are significant concerns about this mangrove ecosystem, including decreasing coverage (Indica et al. 2011, Theresia et al. 2015), lack of knowledge and awareness of mangrove ecosystems amongst community members, conflict of interest among various stakeholders, and underrepresentation of local wisdom in local regulation (Theresia et al. 2015). It is recommended that the strategy for mangrove management will empower local communities

A review of 114 news articles from 14 national websites and local newspapers during 2010-2020 indicated that the most frequently discussed issue was on commodities related to mangroves in South Sumatra Province and Banyuasin District. Issues related to mangroves were centralized in two areas: Sembilang National Park and the Special Economic Zone (Kawasan Ekonomi Khusus) Tanjung Api-Api, formerly known as Sungsang area and both areas are in Banyuasin Regency. The Banyuasin Regency stretches about 1.2 million ha and contains about 130,000 ha of mangroves outside and within the Sembilang National Park. From 2014 to 2019, about 10,000 ha of mangroves have been lost. Mangroves continue to be degraded due to illegal wood harvesting, conversion of land for agriculture and aquaculture production, and livelihood pressures, as communities are heavily dependent on farming and fishing.

CIFOR and partners (Forum Daerah Aliran Sungai Sumatera Selatan (Forum DAS Sumsel)) and Sriwijaya University) undertakes 'Action Research to Enhance Community-based Business Model for Mangrove Restoration in South Sumatra' to develop locally accepted and sustainable business models, which eventually allow communities to generate sustainable income from mangrove restoration and usage in a pilot area in South Sumatra Province. The specific objectives of the project are to pilot and establish a community-based business model to improve community livelihoods and foster mangrove restoration in Banyuasin Regency and to establish appropriate policies and frameworks that are in place at all levels for stakeholders to implement and replicate business models and mangrove restoration in South Sumatra

### **Objectives**

The specific objectives of the project are as follows:

[1]: To pilot and establish a community-based business model to improve community livelihoods and foster mangrove restoration in Banyuasin Regency;

[2]: To establish appropriate policies and frameworks that are in place at all levels for stakeholders to implement and replicate business models and mangrove restoration in South Sumatra.

[3]: To build a baseline of knowledge in Banyuasin Regency through conducting baseline studies on the community, livelihood practices, key stakeholders, financial and economy studies.

To work on the mangrove restoration activities on site level, CIFOR is partnered with University of Sriwijaya. The university is the largest state-owned university in South Sumatra. The research team at University of Sriwijaya has experienced in various project related to mangrove, including restoration in the conservation area within Banyuasin regency that produced the technical guidance documents. The expertises and experiences of University of Sriwijaya research team will be very valuable to strengthen implementation on the ground towards successful community-based mangrove restoration activities.



CIFOR collaboration with University of Sriwijaya is focusing on these following activities:

### 1) Work Package 1 - Participatory Action Research

# **University of Sriwijaya to contribute to implement the community-based mangrove restoration in 50 ha,** includes:

- 1. Identifying mangrove species and specific location for restoration
- 2. Designing and engineering of mangrove landscape restoration
- 3. Developing nursery
- 4. Planting
- 5. Maintaining, replanting, and enrichment planting
- 6. Monitoring and improving

### 2) Work Package 2 – Local Policy and Work Package 3 – National and International Platforms

University of Sriwijaya to participate in the key events of dissemination, policy advocation and capacity building activities at village, sub-national, national, and international level.

### 3) Work Package 4 - Project Management

University of Sriwijaya to participate in the key meetings during the project such as internal project meeting, kick-off meeting, annual meeting, and exit and closing strategy.
